The plasma levels of NT-proBNP were significantly higher in patients who had AF at baseline, with a median of 3417 pg/mL (1897–6486), as compared with patients who were in SR at baseline; both those who had a history of AF (1788 pg/mL [682–3870], $p < 0.001$) and those who never had AF before (2231 pg/mL [902–5270], $p < 0.001$) (Table 1), also after multivariable adjustment (Table 2).
